

- CHELAN COUNTY -MONTHLY FINANCIAL REPORT

The General fund is Chelan County's major operating fund. It has a budget of \$35 million and is comprised of administrative functions, building and planning permits, Sheriff's operations, juvenile housing, criminal prosecution, and the courts. The revenue and expenditure charts below display the 2015 General fund projected budget contrasted with actual expenditures and revenues.

Salaries and wages have been spent at a higher level than projection due to unbudgeted contract work the Sheriff's Office performed for the Public Utility Districts. These costs will be recovered from unbudgeted reimbursement billings.

The majority of the law enforcement contracts and property tax revenues came in earlier than expected and should balance out by the end of the year. During April, sales tax revenue came in as projected while building and planning fees continued to come in





above projection. Overall, these growing economy-based revenues point to a stronger economy in Chelan County than we have seen in the past several years.

A question the County often receives pertains to the percentage of the budget dedicated to "Public Safety". This category could have many definitions depending if you consider the courts and corrections as part of the public safety process. The following chart displays the three major components of the public safety process. Over two-thirds of the \$35 million General fund is dedicated to some part of the public safety process. The "other" category covers all other functions the general fund provides (see the "Actual YTD Expenditures & Revenues" chart on the next page for a listing of all the General fund departments).



The General fund balance chart below shows the cyclical nature of Chelan County's cash flow. April shows a larger increase than expected because property taxes and law enforcement contracts were recorded earlier than most years. For the most part these amounts will balance out. The actual fund balance for May is not expected to remain at \$1.5 million above projection. Taking this into consideration, the General fund is still approximately \$600,000 above projection.



Interfund Loans: While the General fund is doing better than ever, there are several funds that are currently borrowing cash to meet operational needs.

The Noxious Weed fund is currently borrowing \$9,000 from the General fund to meet cash flow needs. This amount should be reduced in May due to payments received in April from the Noxious Weed assessment.

The Natural Resources fund is currently borrowing \$486,000 from the REET I fund to meet cash flow needs. Of this amount, \$138,225 is related to 2014 projects and \$347,775 is related to 2015 projects. Natural Resources is reimbursement driven and as of April 30, had \$97,176 in booked receivables that will go toward paying down the 2014 balance when received.

The Regional Justice Center (RJC) is borrowing \$992,000 from the Criminal Justice Sales Tax and Distressed Counties Tax funds. The General fund increased its contribution for Chelan County inmates during 2015. Contract rates will increase for all inmates housed in the coming years. These revenue increases should help alleviate the RJC's debt.

Budget: April is 33.3% through the year. This can be used as a guideline for departments that have even expenditures throughout the year. However, most departments do not receive their revenue evenly from month-to-month. The chart below can be used by the departments as a guide to track their monthly budget.
