#### V. UNFINISHED BUSINESS

- A. Chelan-Douglas Task Force Policies and Procedures for grant cycle (Action Needed)
  - 1) Approve Task Force Policies and Procedures

The Policies and Procedures Subcommittee reviewed and approved updated language in two key sections of the Task Force Policies and Procedures:

Coordinated Entry: Clarified language related to disciplinary action.

**Allowable Interventions:** Included revisions addressing the Progressive Engagement model and Homelessness Prevention.

The subcommittee recommends the Task Force approve these updates. Updates to the **Budget Categories** (specifically regarding administrative costs) and **Encampment** sections are still under review and will be presented for approval at a later date.

Motioned to approve the Coordinated Entry and Allowable Interventions updates in the Task Force Policy and Procedures by Commissioner Straub; Seconded by Mayor Florea; Passed Unanimously 3-0.

- B. 2025-2027 Funding Recommendations (Action Needed)
  - 1) Approve funding allocations for 2025-2027 grant cycle.

The taskforce discussed applications and funding allocations by funding source. The Taskforce receives funding from the State of Washington in the form of: Consolidated Homeless Grant (CHG), Housing and Essential Needs (HEN), and local recording document fees (2163 funds).

Staff presented one recommendation for funding, developed in consultation with the Selection Committee. Committee members noted the difficulty of the process, describing this as one of the most challenging funding cycles to date. We had \$13,350,001.40 in asks but only had \$11,446,537 in funds. We saw a 9% reduction in what was originally awarded. We have a lot of advocacy to do because current budgeting from Commerce is not sustainable. The recommended option was approved by the task force and will go to the Board of County Commissioners for approval.

Emergency Rent Assistance (ERA) – Due to CHG funding restrictions and program guidelines, the ERA program cannot continue in its current form. The Task Force agreed to pause the program for the upcoming year, with the option to revisit it should additional funding become available.

Motioned by Mayor Florea with the caveat that staff be authorized to reallocate funds within the 2163 funding category as needed for maximum flexibility; Seconded by Christine Johnson; Passed Unanimously 3-0.
