### **Discussion**

Presentation by Renee Swearingen, Entiat Chamber of Commerce with Mat Lyons of TREAD and Kelly Kreuger regarding Chelan County Recreational Ambassador pilot program in Entiat.

Ambassador locations were

- Columbia Breaks / 10 weekends / 218 interactions
- Entiagua / 7 weekends / 376 interactions
- Entiat City Park Day Use Area / 10 weekends/ 1518 interactions

### **Program Benefits**

- Pomas Fire Updates with Maps/QR codes
- Borrow a life Jacket partnership with WS Parks & Boating + Chelan County PUD
- CC Sheriff connections for additional river safety patrols on the river
- Fish & Wildlife connection for fishing season info
- Discovered the city park boat launch QR code didn't work and therefore was bringing in zero revenue

### Future of the Chelan County Ambassador Program?

- Last weekend of June to Labor Day is the sweet spot for having the program in place in Entiat
- Suggestions to have ambassadors in Olalla Canyon for 3-4 weeks (April/May) for wildflowers.

Scoring rubric for upcoming grant cycle – Steve noted that the criteria were Event centric. Recommended having a separate scoring criteria for Marketing requests.

ByLaws – further discussion regarding Meetings. Move them to TREAD office where they have an owl allowing for online meetings. Clarifying words needed in Point 3, Quorum/Voting. Rev 3 will be presented at next meeting.

Framework – reviewed a spreadsheet with projected collections for 2025 & 2026, and moved percentages around to understand actual financial impacts.

Also discussed the use of Reserves. How much should be retained as min Reserve? What is/should be the overage be spent on?
