Discussion held regarding proposed underground lab. Two sites near Leavenworth are being considered, Cashmere and Cannon Mountains. NUSEL proposes a 3 mile long underground laboratory to study underground physics and earth science. Plans are to provide a leading facility worldwide for deep underground projects. NUSEL would provide education and promote scientific outreach to local schools and the public. Construction costs would be approximately \$300 million with a yearly scientific activity of approximately \$50 million, Approximately 200 staff would be needed, with 66% coming from the local work force.
