Chelan County Prosecuting Attorney Gary Riesen, Deputy Prosecutor Susan Hinkle, Planning Director Larry Angel, and Landowner Ken Grosse Meet with Board regarding Whispering Pines Subdivision. It was **consensus** of Board that we will use the Shannon Wilson Figure 4 Site Map with an overlay of Whispering Pines. Chelan County will not identify area in yellow as flood way or flood plain, but identify those areas as a geological hazard area. We will require geological hazard assessments in these areas and will require receipt of a Signed Hold Harmless Agreement prior to issuing a building permit in these defined areas. As these geological assessments are filed they may be used as a basis for any future changes in the Shannon Wilson Site Map Figure Four.

In addition, we will not allow building permits in areas that are described specifically as channels. Landowners must obtain a geological hazard assessment which may be more extensive, as well as the Hold Harmless Agreement. The 1000' setback currently required will be eliminated.

Site Assessments will identify channels as well as alluvial fan with set backs from channels to be 50' unless otherwise recommended in the site assessment. The setback from the alluvial fan will also be determined by site assessment. Chelan County Planning will draw up a draft form for approval on an interim basis and then forward to the Planning Commission for approval.
