# CONTINUED PUBLIC HEARING FROM JANUARY 29, 2008 PROPOSED FEE CHANGES FOR LAND USE PLANNING AND BUILDING

Commissioner Hawkins opens the continued hearing. Community Development Director John Guenther outlines the proposed modifications to the fee structure as proposed at the previously held January 29, 2008 hearing:

- Planning Fees Unchanged; and
- Building Valuation Changes to Reflect 12% or10% Impact
- No Changes to Fee Schedule
- Home Builders' Offer of Assistance in Completing a Cost Recovery Study

The proposal before the Board today is that a given structure or the amount of dollars collected form the Community Development Department as far as valuation would be increased either by 10% (percent deferred from last year) or, 12% (deferred from last year plus a CPI index of 2%). Along with the fee increases, the Commissioners and the Community Development process improvement is shared with the Homebuilders as well as

other entities in the land use business. The information from the cost recovery study needs to be to the Commissioners prior to the next budget session.

# 10:34:54 AM PUBLIC COMMENT:

Gary Isaacson speaks on behalf of the North Central Home Builders' Association on the fee increase. He shares the Homebuilders oppose an increase which may seem to be a small amount. In this scenario the increase could be about \$500 on a 2000 sq ft home which might sell for \$350,000. In the industry there are many things that affect affordability and most of them are uncontrollable such as commodities and regulations. On the local level three things that can be controlled to keep the costs down for affordable housing are a good supply of land, holding down excess regulation, and fees. When the industry reaches the tipping point of affordability it is not one big thing, it is death by a thousand blows. The Commissioners can control those costs and it is requested that anytime you vote an increase in fees it is asked that it is done with careful consideration and good data to support that decision.

Affordable housing incentives were discussed at the last hearing and Commissioner Walter feels these ideas need to be incorporated into further discussions on affordable housing.

Mr. Isaacson speaks about the availability of land and the continuing discussion on changing the growth management boundary as suggested in 1995 between the City of Wenatchee and Chelan County where it was agreed that 1100 acres, of which 380 acres was buildable. These numbers of acres are not enough. This is one reason for the spike in land prices. Commissioner Walter reminds the association of the work Chelan County has done in the changes in Malaga, the reformation of the Manson Community Council, and the Peshastin area. It is important for community involvement when those that do not want growth are challenging the designations of land for housing such as LAMIRDS.

2007-006; 2007-020; 2007-027; 2007-030; 2007-033

Commissioner Hawkins opens public hearing on the proposed comp plan amendments. Commissioner Hawkins discloses a business association with the applicants being heard today. He does not feel that there will be any conflict but would recuse himself if requested. In CPA 2007-006 Commissioner Goehner also notes a friendship with the applicant. He also does not feel this would affect his ability to make a fair judgment on the issue. Commissioner Walter notes a family relationship with Morgan Picton, the representative in 2007-007 and 2007-003. No one from the public requests recusal.

On the hearing of CPA No 2007-027 Commissioner Goehner will recuse himself because he owns property adjoining the parcel being heard for action. Only Commissioner Hawkins and Commissioner Walter will be taking action on CPA 2007-027.

#### **CPA 2007-006:**

2007-006 Graham Simon of the Chelan County Planning Department presents staff report. Application was submitted by Craig Christensen on behalf of Remley Orchards. The proposal is to change the designation of 18.5 acres of land from Commercial Agricultural Lands (AC) to Rural Residential (RR 2.5). The subject property is located on US Highway 2, approximately 1.4 miles west of Cashmere. It is also identified under Tax Parcel No. 241836140020. The Planning Commission recommended approval.

Surrounding designations are discussed. No one from the public speaks on the application.

#### **CPA 2007-020:**

Planner Graham Simon presents the staff report. Application was made by land owners Herold and Marrian Peebles, for a comprehensive plan amendment on approximately 51.92 acres of land. The proposal is to change the designation from Commercial Agriculture Lands (CA) to Rural Residential Resource 5 (RR5). The property is located at the intersection of Boyd Road and Purteman Gulch Section 33 & 34, Township 28N, Range 22, in Manson, WA. The property is also identified by Assessor's Parcels #282233110050 and 282234230070. No owner or agent representation at any meetings. The Planning Commission recommended denial of the application.

Commissioner Goehner finds no documentation of profitability or productivity. There was not any information on soils. No one from the public speaks on the application. Staff did not feel the applicant met the intent of the WAC on de-designation of ag land criteria as well as the surrounding land use would be incompatible.

(Commissioner Goehner has recused himself from the hearing and leaves chambers.)

An application was submitted by Diane Parker, owner, for a Comprehensive Plan Land Use Map Amendment on approximately 21.87 acres of land. The proposal is to change the designation from Commercial Agricultural Lands (AC) to Rural Waterfront (RW). The subject property is located at 8361 Depot Road, Dryden, WA, within Section 26, Township 24N, Range 18. The property is also identified by Assessor's Parcels #241826330050 and 241826340100. Map identified as exhibit. After submittal this property went through certificates of exemptions and each are now individual tax lots totaling 7 lots. The adjoining property is the railroad. The Planning Commission recommended approval of this application.

Attorney Kirk Bromiley represents Ms. Parker and speaks to the application. Written materials were submitted to the Planning Commission. It was earlier thought the staff would

recommend denial, however, the historic lot lines were re-established into 7 parcels). The size of the parcels is smaller at this time. The land is currently in orchard land. Commissioner Goehner has parcels next to this property. Other orchards in the area have been removed. Once parcel is zoned rural industrial with the remaining parcels in commercial ag. PUD water and sewer are already in the vicinity. The changes in the area have moved from ag lands to now a character change and likely to be developed. He feels the Planning Commission recognized that a policy decision should be made to re-designate the property to rural waterfront when they recommended approval. He notes the Chelan County Assessor has recognized this as the property tax increase values tripled. The property is not going to remain in orchard and will be developed in some fashion. As it presently sits there are 7 parcels. Land use planning could be done to create parcels that she can develop and sell. A rural waterfront designation subjects the property to all of the planning and processes that are needed for a subdivision and provides the citizens and the County with all of those protections.

Neighbor Jeff Kinzel speaks as a neighbor to Ms. Parker. The property has logical boundaries with the river, Depot Road as well as the railroad. It also has the necessary services.

Graham Simon gives staff report. An application was submitted by Morgan Picton and Associates, on behalf of Dave Hellyer, owner, for a Comprehensive Plan Land Use Map Amendment on approximately 37.75 acres of land. The proposal is to change the designation from Commercial Agricultural Lands (AC) to Rural Residential/Resource 5 (RR5). The subject property is located at 780 Boyd Road, Chelan WA, within Section 33 & 34, Township 28N, Range 22. The property is also identified by Assessor's Parcels #282233524065, 282234524060 and 282234524050. The Planning Commission voted for approval of the application.

Morgan Picton speaks on the issue. He states the property is not suitable for commercial ag. The amount of property that is prime and unique soils is very limited; there are a lot of steep slopes, and also limitation of irrigation water. The Planning Department concurred that this is

not suitable for commercial ag. The Planning Commission recommended approval at their meeting.

# 2:06:27 PM CPA 2007-033:

Planner Simon offers the staff report on application CPA 2007-033 submitted by Morgan Picton and Associates, on behalf of Richard A Johnsen of Chelan Red, LLC, owner, for a Comprehensive Plan Amendment on approximately 144.68 acres of land. The proposal is to change the designation from Agricultural Commercial Lands to Rural Residential/Resource 5 (RR5). The subject property is located at 992 Winesap Ave, Manson, WA, within Section 32, Township 28N, Range 22. The property is also identified by Assessor's Parcels #282232606295.

The Planning Commission recommended denial of the application. The staff analysis feels this is mostly prime soils and the property is surrounded by ag. The staff felt this would be a spot zone. Commissioner Goehner notes that there are no production records or profitability records submitted on the matter. Mr. Morgan Picton speaks on the proposal. He hands out a 2006 Supreme Court decision on the Lewis County vs. Western Growth Management Hearings Board. He offers what he believes to be pertinent information on page 8 of GMA and ag lands and long term significance. He believes the Planning Department and the Planning Commission rule differently that what he reads in the text. It states that soil is an important issue in designation of commercial ag land and forest resource land but is not the only issue nor should it be the primary issue. The counties should be looking at all of the WAC to make that determination. The staff recommended denial. The owners request a change from ag commercial to RR5. The owners feel that this property is not suited for long term commercial operations and that is not their reason for buying it. The property was not priced as an orchard because the seller also did not feel it is not suited for long term commercial ag. The neighbors also feel this is not suited for long term commercial ag operations because the property around it has been converted to other uses as well. He sites WAC's 365.190.060 and WAC 365.190.050 indicating what other combined affects the County should be considering. He says the land is in a frost area with many wind machines. He does not believe the land is well suited for other crops due to the altitude and topography. He feels the surrounding land would be complimentary to the requested designation. He responds to the question of the current crop, as lands are currently planted in Top Reds.

Pack out records and production records are not available at this hearing as noted by Commissioner Walter.

Commissioner Goehner shares that the property is in the middle of existing commercial ag. There is the option of converting to more productive varieties.

Planner Matthe w Hansen shows that there are large chunks of prime and unique soils of about 60 - 70%.

Commissioner Hawkins states that services are not available at this time. He also shares he has a hard time seeing a compelling case to change the designation. The Commissioners need to meet a high threshold to de-designate the land. It has good soil, it is surrounded by other comparable commercial ag lands, there is not urban encroachment, and there is not extension of urban services in the area. Commissioner Hawkins states it does not meet the threshold.

Commissioner Goehner states that the reference to the WAC decision for Lewis County shows a number of issues that are different than what we are addressing here. Commissioner Walter states this is not compatible with the pattern the Commissioners set for these decisions. The Commissioners have not seen pack outs, productivity information, etc.

Commissioner Hawkins feels that if the decision were made to change the designation, the possibility of bringing this land back into ag land after it is re-designated residential land is unlikely.

Commissioner Goehner shares a similar situation with his property in that the main agricultural enterprise may need to be changed to make a productive piece of ground continue to be a productive piece of ground.
