PUBLIC HEARING-Petition for Road Vacation by Tuttle Property Management, LLC County Engineer Jolene Gosselin-Peterson gives County Engineer's Report.

It is the finding of the Chelan County Engineer that the portion of right of way as petitioned for vacation may be necessary for the future county road system improvements/flood channel maintenance/repair and for a staging area along with historic use by adjoining land owners. It is the opinion of the County Engineer that the County would benefit by retaining this right of way.

9:43:29 AM PUBLIC COMMENT:

James and Gloria Tuttle are present representing their 6 children (landowners). Mr. Tuttle shares that the County Engineer indicated there are a number of roads that residents have shared are a concern for regarding access. He says there would be no invasion of the roadway and this vacation would not hinder the use of the roads. It would be just the eastern edge of the road. He believes those that have indicated opposition may not be owners. Commissioner Hawkins asks the reason behind the vacation request and Mr. Tuttle responds this has been this way for 68 years of this road, the slide is not near this area and, why not? He feels owners have been paying tax on the 46 feet of land. He also feels the landowners can utilize this area for additional parking.

Chris Stahler, one of the petitioners, speaks. All of that right of way may concern people. The 25 foot access that was given in the past does not impede currently. Would the 25 foot compromise be better? That would ease the concerns and he would agree with that.

Jeanne Barnes is concerned about the access to the northern part of the road. Strings (possibly marking property lines) were placed on the road recently which came into the middle of the road making it impossible for access if they were placed on the line of vacation. Her property has been in the family for many years. The surrounding owners have used the road for decades. If they are restricted from that road and have to use the southern access she would feel it would be a safety and traffic hazard. A compromise would be great if the amount of the width in the vacation was decreased and would allow access.

Mary Blackham: Mary Blackham is here today representing Mrachek LLC. Her property is not seen on the map being used today. They live below the road. She is concerned about notice and would like to let others in the area know and inform others so everyone has the

opportunity to participate. This area is primarily family members. She would like continuance so she can make contacts.

James Tuttle: Mr. Tuttle shows a map of the area. He shows He also shows photos of the string lines that do not indicate this proposed vacation goes into the road and the request does not interfere with any lots. They are talking about lots 59, 60, 61, and 62. The surveyor placed the mark of the property and the strings they placed are 46 feet out and it does not go into the roadway.
