9:38:04 AM PUBLIC HEARING: (Continuation) Petition for Road Vacation Tuttle Property Management Co. LLC

Commissioner Hawkins opens that this continuation was to allow time for the County Engineer to look at the area and determine, that since there had been a partial vacation previously and all of the right of way is retained by the County and if it is required for the best use by the County or whether it is appropriate to vacate a portion of that right of way.

County Engineer Jolene Gosselin-Campbell states that the County Surveyor Mark Sele was asked to provide assistance in identifying lot lines. He was able to do so with a tape line for where the 25 foot right of way vacation would lie, which would be consistent with the adjoining property. The County Engineer states that it appears as though the entire frontage road would be contained in the left over 50 foot of right of way for County Road and the pull out area anticipated for use for slide repair would be outside of that. At this time she does not know the future of this road and this is a widened out portion of Lake Shore like some of the area further down, which would mean slope easements would be needed to widen this section. It is outside of the frontage road and it is outside of the pull-out area. There are no plans to do widening there. Her previous recommendation was to retain the right of way. She does not know the future of the area, if there would be a slide, there is a widened area further down which is not being used right now. She would be conservative on this and not recommending the widening but understanding that the County Engineer does not have anything that would show they would widen out the area. As a precautionary measure it would be in the best interest of the County to preserve the option of retaining this right of way. This is a tough recommendation to make. She says that with the 25 foot vacation everyone may continue to use the frontage road and it is outside of the small pull out area. There is a lot happening there and it is difficult to predict the future.

County Surveyor Mark Sele reiterates that if the right of way is vacated the frontage road remains in the right of way and so does the pull out, not in the vacated area. Commissioner Walter responds that regardless of what happens the frontage road is still in the right of way. Commissioner Goehner and Mr. Sele clarifies that if the County were to vacate the 25 feet it has no effect on the pullout or the frontage road.

9:44:18 AM PUBLIC COMMENT:

Mr. Jim Tuttle, applicant, states that at the hearing two weeks ago, he requested the surveyor determine the footage from the NW corner of lot 62 to the slide area. Was that done? It is 300 feet? Mr. Sele shares that he was not asked to measure that and he did not measure from the NW corner of lot 62 to the slide area. Mr. Tuttle feels it is 275-300 feet. Mr. Tuttle understands the Engineer leaning to the future but he requests they recall that this same 25 foot vacation was provided to lots 53-58 thirty-eight years ago. He feels the applicants deserve the same consideration since they are outside of the roadway and there is plenty of room with the pull out. The space will be used for parking, perhaps a shop, boat storage, or things along those lines. (It is noted that there are setbacks from the right of way that may prohibit a shop building). He requests that the Commissioners consider the tax payers' request.

Commissioner Goehner adds that Mr. Tuttle referenced the vacation for 25 feet. They initially requested 46 feet but he is now requesting the 25 foot vacation. The County Engineer shares that when the continuation was requested several weeks ago, the request was to look at the 25 feet specifically.

Mike Holland, property owner, shares he is not necessarily opposed to the vacation but his concerns are if the road were widened at some point in time and this was vacated, the County would need to acquire right of way because it would create a dangerous situation for those trying to leave the area and go up lake. There is really no way to do so without that road being there. As long as that road can stay open on a long term basis, he does not have opposition. He assumes this was done for setbacks for buildings. Mr. Holland would also like to address the process. Summer residents do not see posting when it is not done during the summer when residents are there. He feels there should be proper notice to the property owners. As long as the road can stay open in the future he is not opposed.

Donald McArthur, resident, has concerns with the access to the north but it appears as though the 25 foot vacation that is being requested does not impair that access. For that reason, as a homeowner, he does not have an objection to the vacation.

Commissioner Walter clarifies the property lines involved in the request. Noting on the map it is shown where the toe of the slope is located if this were widened and that the road would be compromised. If the main road were widened the main road would have to slide over and be restricted on the lake side.

 Surface and Stormwater Management Utility (Charges and Credits). Revenue generations are discussed as well as benefit to storm water control and maintenance. Commissioner Goehner moves to approve 85% credit limit to those on this storm system along 97a in Sunnyslope that share a separate, common system, and seconded by Commissioner Walter for further discussion. This motion is subject to legal approval. Commissioner Hawkins feels this will create a huge problem due to equity and application. Commissioner Goehner feels this credit is appropriate for that particular geographic area. This is not an owner that has a self contained system. The properties the Commissioners looked at are part of a larger system that is being maintained by the State, and it is very clear who is a part of that system and who is not. Those that are within the Sunnyslope area that are either uphill or downhill and they if they have their own self contained system it is appropriate to give them the 59% credit but he does not feel it is appropriate to give them the maintenance credit because they are benefitting from the maintenance that the county will do within that area. They are benefitting from any capital improvements because they said they won't be having water running on to their property nor will they be contributing to the other and as long as that is being maintained then there is an adequate system to take care of the run off in that area. If this is a legal issue than 85% is not appropriate for a system-wide credit. Commissioner Walter feels that Commissioner Goehner needs to clarify the motion to include the wording that those areas on 97a that are completely self contained. Commissioner Goehner agrees. Paula Cox does not feel it can be specific to one area but rather language can state certain criteria can be made but it would have to be utility wide. It is before the Board to approve a credit of 85% for industrial users meeting certain criteria that at a minimum would have a fully regional shared system. The problem Commissioner Goehner sees with making this system wide is that he does not believe the same type of credit is warranted because others are receiving benefit from the maintenance. These users are not receiving benefit of the maintenance. There are approximately 12-20 owners that are part of this regional self contained system through an LUD (but they do not have sewer). Commissioner Hawkins and Commissioner Walter are in agreement to give direction to Project Engineer Paula Cox to amend the draft proposal. The motion is withdrawn. Commissioner Goehner was willing to concede the 15% because everyone benefits because the County is cleaner due to storm water clean up. Commissioner Walter and Commissioner Hawkins as a majority would support a 75% maximum credit limit.
