Mr. Reathaford shares the Mike Willet presentation to Pest Board. He states that finds of Apple Maggot (no adults) in Chelan County and details are discussed. Apple Maggot has not been discovered in Douglas County. Hawthorns are the major host for Apple Maggot. GF120 has been found to be successful in apple maggot control.

Vicky Vehrs has worked on the Apple Maggot trapping in the past. The problem is in pears and apples regionally and not just in Chelan County. Douglas County has been trapped as well.

Mr. Reathaford explains that the meeting today is for informational purposes and to inform Chelan County Commissioners the needs for funding. The next meeting of the Chelan/Douglas Pest Board is scheduled for July 2 at 7:30. The regularly scheduled meeting is held on the first Friday of every month at 7:30 a.m. All commissioners are invited. Further concerns are voiced regarding the work to be accomplished in maggot eradication.
