# 1:32:14 PM BOCC CONTINUED HEARING - Title 15 Road Standards

Commissioner Hawkins opens hearing. He thanks the staff and the Committee for their work. He also shares that this hearing will mostly likely be conducted as a workshop with continued input from the group and the community. The Planning Commission sent the document back for further work by the Committee. The Commissioners assure the community members that they are committed to resolution of the matter and a document that serves all the interests of Chelan County.

Public Works Director Greg Pezoldt shares the process thus far. The motions by the Planning Commission are noted.

Parts 1-8 will be addressed. The committee made suggested changes as a group as well suggested changes by individual members.

- Part 1 General Information. Deanna Walter has opposition to 15.30.160
- Part 2 County Road Classification and Design Criteria. Needs review
- Part 3 Access and Intersections. Needs comment review
- Part 4 Pedestrian Facilities Walkways and Trails. No comments
- Part 5 Bridges and Drainage Structures. No comment
- Part 6 Construction Plans. No changes
- Part 7 Construction Control and Inspection. No Changes
- Part 8 Roadside Features. Striping and public right of ways may need change 15.30.875
- Part 9 Traffic Mitigation and Impact Studies. A great deal of discussion is needed for possible changes

The committee will meet again to come up with suggestions and comments. For the committee opinion there may be majority view, minority view and the public works will give their opinion separately. It is suggested that a facilitator take care of the meeting. Shirley Berg of Public Works will act as facilitator. It would be helpful to have Public Works present to help with decisions as to criteria and regulations. One meeting will be held and those that have attended will be invited to come and add in this final input. Public Works Director and the County Engineer will attend with the Public Works Director responsible for writing up the documents.

Mr. Dennis Reynolds, representing the Homebuilders' Association shares his view with the Commissioners. Until recently he was a partner in a national law firm, prior to that he was a partner in a Seattle firm, he was an Assistant Attorney General representing major environmental cases, had state agency experience, and attended the U of W Law School. He has represented building industry and organizations, realtor organizations, and given Growth Management Act guidance at the county level. Clearly the building industry is obligated to provide project mitigation. How do we get there is the question. 2008C-8a

He respectfully submits that the Commissioners defer action now on section nine and look at the level of service standards in the Comprehensive Plan Update when it is completed which is scheduled December of this year. The levels of service standards are being reviewed. They should be established in the Comprehensive Plan. Commissioner Hawkins clarifies that The TransPo group is currently working on them.

Commissioner Hawkins questions if the balance of the document can be adopted prior to the adoption of Title 9 and questions what does that do to the projects that are in the cue or will be in the que between now and that time.

Mr. Reynolds states that as he sees it, Chelan County has on its books, a well thought out and well drafted State Environmental Policy Act Ordinance. In that ordinance Chelan County provides for the authority of SEPA including on and off site traffic mitigation. The ordinance is well drafted by the Office of the Prosecuting Attorney. It has been on the books for years. The industry knows how to deal with that ordinance as well as staff. He would also recommend we do not need to repeat in County Road Standards what is already on the books. The generic standards are already on the books. Implementing the standards on a project by project basis will work. So he also recommends that the County continue using the SEPA ordinance process to evaluate and impose project mitigation so new growth pays its fair share for impacts directly related to a project.

His third recommendation is that once the Comprehensive Plan Update comes back there may or may not be a reason to develop some new standards to implement level of service requirements. At that time you could look at section 9 and see if some of it is appropriately used as an implementation device to deal with level of service requirements. If you tighten up level of service

you may want to consider some standards changes in addition to the SEPA Ordinance to give guidance to the process.

Counsel Lou Chernak will review the document and make suggestions.

Commissioner Goehner states the issues we continue to struggle with are the on and off site mitigation. In the letter submitted by Mr. Reynolds, he feels we currently exceed accepted legal standards in the on and off site mitigations. The issue we deal with is what is significant and what is insignificant. At what point does it become significant? Mr. Reynolds shares that he does not have a better definition than does the County. He clarifies that his comments are out of the accepted legal standards is only in relation to the draft. What is on the books now has a "pass to go". Looking at the project and determining the impact is where you should determine project mitigation such as design standards, accident statistics, the volume of predicted traffic, and is this project really going to have impact. If you are going to drop the level of service you need more definition.

Commissioner Hawkins states that with our work on level of service with the TransPo Group we are giving direction to them in terms of level of service to look at the condition of the road for current use and what would be the additional impact on that road from the new development to determine the amount of share of upgrade that developer should pay instead just looking at linear capacity of the road. We need to look at the condition of the road in comparison with the standard of the road would be for developments of that type along the road. Mr. Reynolds has concern in our rural roads as to how much should the new development bear of costs of bringing a low grade road up to current standard. That is a tough question. Engineers would say new development is the only way to bring it up financially in the capital facilities plan.

Commissioner Hawkins states with the rural roads we have in the County and have proposed developments coming in, we have three options, either that the developer shares in the cost for upgrades for the road by voluntary mitigation, let the development go as is and add to an already bad situation, or we deny the project.

Mr. Reynolds likes the voluntary mitigation option. Mitigation requirements should not be part of a document that describes design standards. You already deal with mitigation in your SEPA ordinance, why duplicate it in the road standards which are design standards. The general principals in the letter are pretty well accepted, but the application is not without debate. If you try to change the generic standards to get rid of some of the debate in the system, it does not work.

Commissioner Goehner speaks on the nexus and the direct impacts of the project. The developer may have a 40 lot subdivision, developing off a road that has capacity, and it falls within the standards of the road. Then you have another developer that has 6 lots and he is off on a more rural road, and there can be a significant impact to that road and the one that has the 40 lots does not have the obligation because of the location of that property. Both developments are

impacting the overall system but it appears that there is no real mechanism to bring that level of proportionality for the total traffic picture responsibility.

Mr. Reynolds responds that there are two solutions provided in the law in the State Environmental Policy Act (SEPA) and you can do voluntary agreements which are allowed by RCW 82.02. You can also consider a traffic impact fee ordinance. That has not been the solution of Eastern Washington and he personally feels it is a wise policy decision not to do that. There is not a generic standard that is going to answer all of the questions on these issues. It is the climate we have in the county for asking the building industry to make some reasonable accommodations. It is also comes down to the general fund and road transportation money which is tight.

Commissioner Walter speaks on the example of the flawed curve. A developer wants to develop and they have identified the need for the developer to participate in fixing the curve. We know there will be more demand in this area that is accessed by the road and by going beyond what is needed to fix the problem to accommodate the current development and we want to go a bit further and open up the road to access potential future development. The future developer then has the ability to access that road that has been developed and improved without contributing. Our late comer's agreement actually allows development to become a beneficiary of what the county has done.

Commissioner Hawkins discusses Mr. Reynolds' letter questioning the legality of requiring a right of way dedication for a half street improvement project.

Mr. Reynolds shares that is only in the draft now and he believes that document goes too far. He believes it can be required in the right context. He believes it is a proportionality issue. His comments on that matter relate only to the draft language.

David Honsinger of the Department of Transportation asks about the timeliness under SEPA for pro rata mitigation. How long can the County hold on to mitigation dollars, for 10 years? 20 years? There is no answer to that. Under 82.020 it is six years but that is not playing under that standard. SEPA states it is reasonable mitigation. The courts would probably go by analogy to the 6 year period in 82.020 in Mr. Reynolds' opinion.

In summary Mr. Reynolds would recommend that the committee bring forth a set of alternatives so the Commissioners can adopt Title 15 1-8, operate with SEPA as a mitigation road map until such point in time as the County gets the TransPo study completed. If the County decided to do more work on implementation of the current requirements he would suggest they not do that in the road standards.

Commissioner Goehner shares that Mr. Reynolds has suggested in his letter the draft of section 15.30.620(a) illegally shifts to private citizens Chelan County's responsibility. Mr. Reynolds shares he just wanted to bring that to our attention and flag that item. Lou Chernak can take a look at that.

Commissioner Walter talks about the opinion not to adopt section 9 until after the Comp Plan has been updated. However, Mr. Reynolds states he does not feel that they need to wait but more to have an additional look at it after the Commissioners have done the Comp Plan Update. Commissioner Walter shares that some of the things we have included in section 9, and in Mr. Reynolds' letter he states that, except for generally stating that new development will pay its proportional share for mitigating impact on existing road system found in purpose of section 15.30.910 the specific language in this section violates each and every one of the legal standards that your have set out. Commissioner Walter shares that included in section 9 is all of the language about traffic impact studies. Under our current document if we did not include that portion of it we would be in error. Commissioner Hawkins shares that section 9 could become traffic impact studies as a separate chapter. Committee member Dan Beardslee states that could be a task for the committee and that it is close enough. There will have to be most of chapter 9 other than mitigation should come forward out of the meeting. The latecomers were done by resolution so that does not need any change. Basically, the mitigation portion of chapter 9.

Commission Goehner appreciates the willingness of the committee to continue working on this until completion.

Greg Pezoldt shares the Planning Commission comments on the Appeal of Decision by the Deviation Board. Composition of the Deviation Board is discussed. The committee felt that there were an unequal number of county participants for the vote to be equal. More discussion will follow.
