2:00:31 PM AG TOURISM HEARING - Chelan County Community Development

Commissioner Hawkins opens hearing. Present are members of the Ag Committee, Hank Manriquez, Robin Grahamson, Steve Hair, Gordon Goodwin, Laura Mrachek, Mike Mrachek, County Planning Staff Lilith Yanagimachi and Director John Guenther, Commissioners Buell Hawkins, Ron Walter and Keith Goehner, and Clerk of the Board, Shiloh Burgess representing 12th District Senator Linda Evans Parlette, as well as concerned citizens Natalie Bennet, and Patrick Walker.

John Guenther shares that a workshop was held on Monday, September 22. The purpose is to take a look at the legislation of the Code (mainly Title 11) and the segments that deal with Ag related activities, especially the value added portion, and the impacts that they can have within the Ag community. The Board had worked in this area in the past and from that work came Senate Bill 6237. The Board has been interested in Legislative changes due to the ongoing changes in wineries and how they are being used. State Legislation discussions are taking place as well on other value added uses. In order to capitalize on the Commission initiated request for a text change, a community group was brought together to gather input. The attempt through this new legislation would allow a dialogue to occur that addresses the value added applicants and the Ag community to work out land use actions together. In order to accomplish this, a permit and Ag tourism reference book was created. That is contained within this legislation.

Public comment was received from Guy Evans in support of the proposed legislation as well as comments from Gordon Goodwin, Patrick Walker, Gwen Clear of the DOE, and from William Roberts.

Staff member Lilith Yanagimachi summarizes the new staff report which added the workshop comments. A draft resolution is included for review and consideration by the Board. Suggested changes and additional comments are placed in the record. No SEPA comments were received. All hearings have been duly published. Guy Evans submitted a letter into the record in favor of the changes, Patrick Walker submitted some suggested changes for community trails and bike facilities as mitigation measures, and submitted items previously viewed by the Board.

Commissioner Hawkins shares the protocol for today's hearing. Commissioners have no questions of staff at this time.

Representing the office of Linda Evans Parlette, Shiloh Burgess, reads a letter from Senator Parlette into the record. This letter includes the current, broad State definition of a winery as follows: RCW 66.04.010§42 states "winery means a business conducted by any person for the manufacture of wine for sale other than a domestic winery". The Federal Government, however, has four specific classifications in the wine industry:

- BLENDED WINERY Producing wine for sale (crushing, blending, aging and bottling)
- ALTERNATING PROPRIETOR Making wine for commercial purposes, often times sharing a facility with other businesses
- CUSTOM CRUSH CLIENT (Wholesaler) individuals who have grapes or other wine making materials that they would like to have made into wine, but would prefer that someone else make the wine for them. The Bonded Wineries that produce the wine for the wholesalers are known as Custom Crush wineries

• A BONDED WINE CELLAR - Bonded storage warehouse established to store, blend, or bottled un-tax-paid wine

Senator Parlette recommends that Chelan County consider adopting the following language for the code, under definitions, to be in agreement with Federal Law and perhaps future State Law:

14.98 "Winery" means a facility where fruit or other products are processed (i.e. <u>crushed</u>, <u>blended</u>, <u>aged and/or bottled</u>) and may include as incidental and/or accessory to the principle use, a tasting room, food and beverage service, places of <u>public/private</u> assembly, and/or retail sales area.

Community Development Director John Guenther shares that he has been discussing the matter with Jean Leonard with the Washington State Wine Institute who has been working with the Liquor Control Board to come up with a definition that works in a number of areas.

Robin Graham would like to go on record as supporting this proposed definition. He believes he brings a new perspective for those in his age group who are moving to learn where the food comes from which brings an increase in consumption of Ag products. This would allow more farmers in his age group to build wineries and expand as the business expands.

Commissioner Goehner shares that the need for this arises from small businesses that need to put in the value added operations for another activity to augment the farming operation. This was the intent of Ag tourism. By making this definition into one or two of the processes it can be expanded as someone becomes more successful. They can still maintain the home site.

Gordon Goodwin reads his letter into the record regarding negative impacts to existing Ag operations with the addition of new Ag tourism land use activities. He promotes a 300' buffer for mitigation/protection.

Patrick Walker, with the Chelan/Douglas Land Trust and Friends of Our Community Trails, states this is a good opportunity to create a partnership between agriculture and the effort to create community trails and the community to come together for mutually benefited goals. Ag tourism is a tool to learn where food comes from for the public benefit. He would like to see this partnership placed in the document for community trails as a valued added amenity of itself. To donate a portion of the farming property for trails would be a benefit to the land owner as well. Access for non motorized trails would also reduce traffic and could be used as a mitigation factor (which is in page 6 of the document for traffic mitigation). There is a link between bike paths and Ag tourism. This can be a choice for the owner/applicant to participate.

Mike Mrachek speaks in favor and approves of the proposed changes. He feels that Ag tourism is a huge industry in this county. He will be making wine on his property next week and their property should not have any problems falling under the definition of a winery.

Commissioner Goehner shares his concern that the Commissioners will continue to wrestle with the other activities such as the public and private assembly. The Ag tourism and the activity in a winery do not seem to be as much as an issue as the other activities of public gatherings. Mr. Mrachek states they had five weddings this year and probably will not have any next year. There may be family weddings there in the future. They did not have much in the way of amplified music this year. They probably will have no more concerts. He states there is a lot of liability with concerts and the weddings are "a pain".

Commissioner Goehner is not speaking specifically to his operation but more to the whole context of Ag tourism countywide. There is typically a conflict with a high concentration of people for an ongoing activity. It does then create the potential for more conflict. This is one of the difficulties to address within this proposal. Commissioner Goehner has a great concern for the family farmer that is impacted. But he also wants to maintain the viability of farming.

Mike Mrachek states it takes common sense – churches, schools, and other things - go on in the way of public gatherings in the middle of orchards and have been for many years. It just comes down to common sense.

Laura Mrachek begins her comments in reference to adjacent uses, change of use and respect of existing use. That is very important. Mr. and Mrs. Mrachek began with 40 acres of cherries. They know how difficult it is to make a go of it on a small number of acres. They are farmers that got involved in grapes for the same reason everyone else did when the apple prices were low. They had to go there to create a sustainable farming unit for the future. They have their operation in Malaga and some of it grew bigger than they expected. She states sometimes you have a success and you don't know how it got there. Mrs. Mrachek shares she is not saying they couldn't be better neighbors and wineries couldn't be better neighbors. Everyone can be quite good if they choose to be. On the agricultural neighbor good practices section with the review committee, (page 5 of 7) she would like to see the wording changed from "non agricultural" commercial to "agricultural related" commercial and retail uses.

Commissioner Goehner adds that striking the words "non agricultural" to plainly state review "activities" and establish... It is **consensus** this is appropriate wording for the text.

Commissioner Walter states that Chelan County has tried to give the tools to the Ag community to allow them to react to the economic environments and re-invent themselves. It is important to be able to bring diversity to the family unit and diversify income to keep the operation going. He adds this is a living, changing document.

Hank Manriquez of the Cascade Foothills Farmland Association has been involved with this procedure for many years. He was involved in the Blueberry Hills discussion and after one and one half years, new rules and regulations were made. The question he has for the

Commission is – will they be sending this back to Olympia to change it at the State level as they did before? Senate bill 6237 was the needed change years ago. Cascade Foothills Farmland Association supports this change. The growth is here and is a good thing.

The Commissioners respond that this is a good document mainly relating to the definition of a winery and will suffice under the original bill.

The Commissioners share that we have land use applications for wineries in the queue, making it necessary to define "winery" at this time and not wait for the legislature to act next year. This document will maintain neutrality with what is happening at the State level. At some point, the State definition of a winery will take precedence. Changes of the use chart will now reflect 1500 square feet.
