#### **Monitor Water Project Public Hearing - Close Out**

Commissioner Walter opens the public hearing. This public hearing is a requirement of the Washington State Department of Community, Trade and Economic Development to close out the \$1 million Community Development Block Grant for the Monitor Water System Project. Chelan County was the grant recipient and Chelan County PUD administered the grant through a sub-recipient agreement that was effective August 27, 2007.

Mr. Jeff Smith, PUD Manager of Community and Intergovernmental Relations offers three original copies of CTED's Grantee Closeout Performance Report for signature. Extending water to the Monitor area dates back to 1994 although the most recent effort began March 30, 2005 with the first meeting of a multi-agency task force, including Chelan County, which worked tirelessly to bring this longstanding dream to reality. Installation of the system by project contractor Bruno Construction of Snohomish officially began January 21, 2008.

Members of the project team are introduced as follows: Community Relations Administrator Jackie Tupling, Project Engineer John Goodwill, Treasury Analyst Heather Irelan and Brian Karcutski of Accounting.

Engineer John Goodwill offers a report on the construction process indulging total feet of pipe installed in project as well as locations and challenges in the construction process. However, even with the challenges faced in construction the project came in under the proposed budget.

Community Relations Administrator Jackie Tupling shares the project details of service. She reports 87 meters will be activated in the system and 129 meters will be activated at a later date. The pipeline, water services and fire hydrants have been tested and accepted by the PUD. Customers are now installing service lines to connect their homes and businesses to the system.

Accounting Analyst Brian Karcutski adds the original 2007 \$6.5 million budget was reduced in March of 2008 after internal administrative costs came in lower than expected and the construction bid was under estimates. He shares the seven different funding sources for the project:

- \$ 500,000 Water System Acquisition Rehabilitation Program Grant
- \$ 573,000 State and Tribal Assistance Grant
- \$ 800,000 Legislative Appropriation Grant,
- \$1,000,000 Community Investment Fund Grant,
- \$ 483,134 Commitment Chelan County PUD,
- \$ 200,000 Chelan County Grant
- <u>\$1,717,640</u> Drinking Water State Revolving Fund Loan \$5,273,774. Funding Total

Treasury Analyst Heather Irelan presents her report on the LUD process. The \$1.7 million loan will be repaid by property owners within the Local Utility District which was formed by the PUD Commissioners in July of 2007. Property assessments won't be finalized until construction costs have been tallied. Assessments will be calculated and the final LUD hearing before the PUD Commissioners will hear customer concerns and appeals. Annual assessments will be over a 20 year period with the option to pay monthly or, annually with a low cost interest rate. PUD commission will hear additional comment for LUD customers. The average payment for customers have been revised from the updated budget of \$28 per month and now due is a monthly amount of \$22 per customer.

Commissioner Goehner appreciates the coordination and work by the PUD as a satellite provider. Feedback from the community has been positive. Predictable water has been an enhancement for the community.

Mr. Jim Bailey from the Monitor Community Council adds that the process and system are great and it offers the fire protection that has been needed.

Jack Pusel shared that there was a lot of community misconceptions, but this has been a great project. He spoke with Bruno often and they did a great job.

Commissioner Walter is pleased to see this project come in under budget and the cost to users being less than anticipated. This shows good job management and oversight.
