Present are Marsha Clute, Gary Riesen, Dave Griffiths, Michelle McNeil, and David Witt of KOA Campground. Mr. Harris shares the following information and discussion items:

- State Parks received letter from Commissioners opening discussion on operation
- The Senate budget includes reduction of the Parks budget of \$283 million including reduction of operating budget of \$28 million
- Park mothball was based upon the reduction in the amount of \$23 million.
- Additional revenues for park operations may come from new program called opt out program through licensing
- Lake Wenatchee and Confluence are "at risk parks"
- Squilchuck Park is one that is slated for closure and is open to all options for discussion for Squilchuck Park.
- Confluence Park is part of the FERC Licensing for the Chelan County PUD and it is required to be operating
- Confluence would revert to the PUD if it were closed or mothballed
- Funds have been set aside to mothball Squilchuck Park
- Lake Wenatchee sites are \$22-28 per night depending on services and have 200-250 sites
- Confluence Park has 86 sites
- A public hearing will be held regarding Squilchuck Park and interest in management of the park
- Further discussions will continue on park management when more budget information is available.
