The code states that primitive and forest service roads are not considered adequate access for issuance of development permit. The code in 2000, and reaffirmed in 2007, shows the Community Development Department proposed language to modify the code and allow residential uses and accessory structures. The Public Works Department reviewed the language and concerns were shared regarding the discrepancy in the county code and state law. It is the direction of the Commissioners to allow the change in the code. Currently, the code does not allow development permits to be issued unless the roads are brought to standards. The proposed language would keep the language in Title 11, and write exceptions for single family residences, accessory structures related to single family residences, Ag structures, and public essential services. This has been put into the subdivision section revisions.
