# 2:02:56 P.M. Chelan Airport Urban Growth Area Expansion Workshop

The City of Chelan is preparing for adoption of the new Airport Layout Plan (ALP) for the Lake Chelan Airport and implementation of Alternative B, which includes extension of the runway. Successful implementation of the ALP will require collaboration among the City, the Port and the County. The airport is a component of the regional transportation network; the location of the airport, approximately three miles northeast of the City's contiguous boundary and surrounded by unincorporated Chelan County, means that any change in the airport boundary must involve changes in both City and County development regulations; the location at the City/County interface also raises issues regarding safety and appropriate land use; the ALP calls for re-location of a County road (Howard Flats Road).

Chelan Mayor Bob Goedde begins the presentation on the City of Chelan Airport which is operated in conjunction with the Port District. The issue today is the protection of the airport into the future. Mayor Goedde introduces Michael Steele of the Chelan Chamber of Commerce. Mayor Goedde shares that John Farrell of the Pilot's Association was not able to attend today but would like to share that this airport was named "the Best Little Airport in the State of Washington" several years ago and would like to maintain that title.

Chelan Planning Director Craig Gildroy introduces other individuals involved and able to answer questions - Chelan Port District Commissioners Mike Armstrong, Chelan City Administrator Jim Reinbold, Consultants with USKH doing the environmental assessment Lisa Corcoran and Ken Nichols, and Pat Moore of Pangborn Airport are present. The purpose of the presentation is to share the City of Chelan's work and changes to the Comprehensive Plan, support the Airport Layout Plan and approved in concept by the Airport Board and the City of Chelan. They will be asking for more public involvement as the process continues. This process is not only to extend the airport layout but to protect the airport in the future. The goal is to move forward with the Urban Growth Boundary Expansion, and the Comprehensive Plan Amendments to accommodate the Preferred Alternative identified in the Layout Plan. This also involves an Overlay District Map as part of the City's Comprehensive Plan to be forwarded to Chelan County, and adopting the Airport Overlay Map Zoning District for expanded runway to insure the correct level of protection is provided. 20090817C8-1

Mike Armstrong of the Port District shares the Port, as a partner with the City of Chelan, financially supports the airport as well as the proposed expansion.

Lisa Corcoran of USKH speaks to the Chelan Overlay Zone and the FAA requirements.

David Miller of the Airport Committee speaks on the planning process to date.

Mr. Gildroy states the City will not be submitting the ALP for adoption this year but will request that the following year. However, this year the UGB Expansion will be requested for adoption for only the properties the airport will be purchasing which is mostly owned by the City of Chelan. The overlay map would be requested to follow.

The Urban Growth Boundary goes hand in hand with the Environmental Assessment and the City would like to move forward with the Urban Growth Boundary Expansion to support the Environmental Assessment which can be done at a parallel track.

Eric Johnson of the Washington State Department of Transportation and Aviation speaks on the airport land use compatibility. This work is to comply with the safety requirements of the FAA.

Wayne Gombotz, property owner, speaks regarding the condemnation process. The Gombots own 34.6 acres in Eagle Creek and have plans to develop a vacation equestrian rental business. Mr. Gombots submits documents objecting to the condemnation proceedings and requests a postponement.

Michael Kane, property owner and county employee speaks regarding his property. He feels his property has been undervalued due to landscaping and trees which will be lost. He also does not approve of the project as he believes it will encourage increased driving speeds.

Betsy Steele, a resident of Eagle Creek Road states her objections to the project, she believes the traffic study is incorrect, the project cost is too high, and the environmental impact will be detrimental.

Grace Hinthorne, property owner speaks in support of the project and believes it will improve safety on the road.

Commissioner Goehner speaks regarding the process of the Eagle Creek Road project and the efforts by the County to work with property owners to design a road that would be safe.

Prosecuting Attorney Gary Reisen answers questions regarding the SEPA and NEPA legal requirements. Commissioner Goehner questions the appraisal process used to determine the property value.
