PUBLIC HEARING: Updating Fireworks Code

Chairman Goehner opens the public hearing. Numerous members of the public are present. The Commission, with the concurrence of Sheriff Burnett, declares the County a High Fire Hazard Area. Fire Chief Arnold Baker with District No. 5 speaks on code changes. Commissioner Walter suggests minor changes to fireworks code at this time but not a major re-write of the code. Mike Burnett speaks to revision suggestions from Fire Chiefs and follow through from last year. George Wilson asks whether enforcement will be by code enforcement or deputy enforcement. Commission clarifies that enforcement will come from the Sheriff's office. Jan Haven with Fire District No. 5 recaps the process and chain of events of putting fireworks ban in place from last year. Martin Albert asks if ban is in place for this year or next year. Commissioners clarify that this year has already been taken care of with declaring the County a high fire hazard area and are currently discussing ban for next year. Jerald Farley speaks on behalf of the industry and again asks for clarification on declaring a high fire danger area opposed to waiting one year for effective ban. Don Flick, Forest Ridge property owner speaks to short notice on conditions and homes lost to fires in the years past. Public Comment period is closed.
