VAR 24-443 Apgar - An application for a Variance was submitted to requesting the reduction of the required front yard setback along N Shore Drive from 25 feet from the property line to 10 feet from the property line in order to build a new garage. The subject property would qualify for a slope setback reduction pursuant to Chelan County Code (CCC), Section 11.88.040(2)(B); however, this slope reduction would only allow the setback to be reduced to 15 from the property line. Based on the slope of the property and the location of the existing single-family residence and an existing chimney attached to the existing residence, a 10-foot setback from the property line would allow for the owner to build the proposed garage and would allow for a safe setback distance between the existing residence and chimney and the proposed garage. The subject property is located within the Rural Waterfront (RW) zoning district in Chelan County. 17725 N. Shore Rd., Lake Wenatchee, WA 98826; Parcel No.: 27-16-14-700-470.

AA 24-466 Wiggins - A request for an Administrative Appeal was submitted to appeal the denial of a short-term rental (STR) permit.
