- 1. Welcome and Introductions
 - Vice Chair Ed Martinez called the meeting to order.
- 2. Public Comment
 - There were no members of the public present.
- 3. Review Meeting Summary from May 16, 2014
 - The previous meeting summary was approved, by consensus.
- 4. Steering Committee Organization
 - Chair resignation.
 - Kurt Blanchard resigned as chair, due his current responsibilities and prior commitments at work.
 - It was motioned and seconded for Ed Martinez move to the Chair position; all were in favor. The Vice Chair position will be left vacant for the remainder of the planning process unless a need arises.

5. Plan Review

- Christina reviewed the plan maintenance strategy. All the changes proposed in the draft were accepted by consensus.
- Risk assessment exposure analysis results
 - Rob presented risk assessment results for earthquake and flood. It was stated that
 the wildfire risk analysis will be a separate but integrated process with the CWPP.
 And that remaining results will be provided at the next meeting.
 - Rob and Christina explained how the County and individual jurisdictions can alter their respective risk ranking scores in their individual annexes to accurately reflect risk, based on local knowledge and history.
- Mitigation Catalog Develop strong mitigation actions by reviewing alternatives
 - Christina reviewed the catalog of risk reduction measures. She explained this catalog provided the planning partners different mitigation alternatives to consider for their communities, which is requirement of the planning process.
 - Rob explained the difference between preparedness, mitigation, and response. A
 mitigation action must be a long-term, sustainable action that reduces loss of life
 and property.
 - The updated mitigation alternatives catalog will be presented to the planning partners in the draft plan.
- Phase 3 Annex workshop dates
 - Rob will attend person, the last week of July, to support the completion of annexes.
 There will be multiple workshop sessions held. The workshop is mandatory for planning partners. Invites will be sent out as soon as the meetings are scheduled.
