2. Steering Committee Organization – The steering committee reviewed the purpose and expectations of the committee. They discussed the draft ground rules and made the following decisions:

 - Public comments will be taken prior to the initiation of each meeting
 - Meetings will generally be the third Thursday of each month from 12:30-2:00 PM at the Confluence Technology Center. The next meeting will be on April 18th.
3. Plan Review
- Hazards of Concern
 - The steering committee was asked to discuss and confirm which natural hazards would be included in the updated HMP. Christina Wollman reviewed the hazards included in the 2019 Chelan County HMP and the hazard maps included in the 2023 Washington State Hazard Mitigation Plan.
 - The committee discussed hazards of concern but did not confirm which hazards would be included in the update. The topic will be discussed further in the next meeting. The steering committee discussed the following:
 - Committee member Ed Martinez suggested adding wildfire smoke as a stand-alone hazard in the plan update. He provided information from a recent survey focused on smoke that was hosted by the RC3 organization (included as an attachment to this meeting summary). Consultants Christina Wollman and Rob Flaner explained that wildfire smoke should not be a stand-alone hazard in the plan due to the nuanced nature of wildfire smoke, inability to effectively mitigate against it (wildfire smoke coming from different regions), and that ultimately, smoke is a secondary, cascading impact of wildfire. The idea of a wildfire and smoke chapter was discussed. Rob and Christina suggested having a more robust discussion of the impact of wildfire smoke within the Community Wildfire Protection Plan (CWPP) planning process to be included in the wildfire risk assessment chapter. The wildfire chapter and CWPP will be updated by the (CWPP) sub-committee in a separate, but integrated, planning process.
 - The Severe Weather hazard was discussed by steering committee members and it was suggested to have a separate chapter for extreme temperatures (heat and cold), especially considering the recent casualties in Chelan County and the ability to quantify this hazard with graphics and statistics such as heat domes. The committee discussed that other weather events such as snow are not considered a local hazard.
 - Mission Statement, Goals, and Social Vulnerability
 - These agenda items were not discussed and will be included in the agenda for the next meeting.
4. Next Steps
- At the next meeting the Steering Committee will choose which hazards will be included, review mission statement, review current plan goals, review the current plan and state HMP review, define social vulnerability.

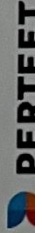

Between February and March 2024, the Residents Coalition of Chelan County (RC3) conducted an online Wildfire Preparedness and Readiness Survey. The survey link was shared on the RC3 website, websites of other non-profit organizations, and various social media platforms targeting residents of Chelan County. A total of 288 Chelan County residents from across the county participated in the survey.

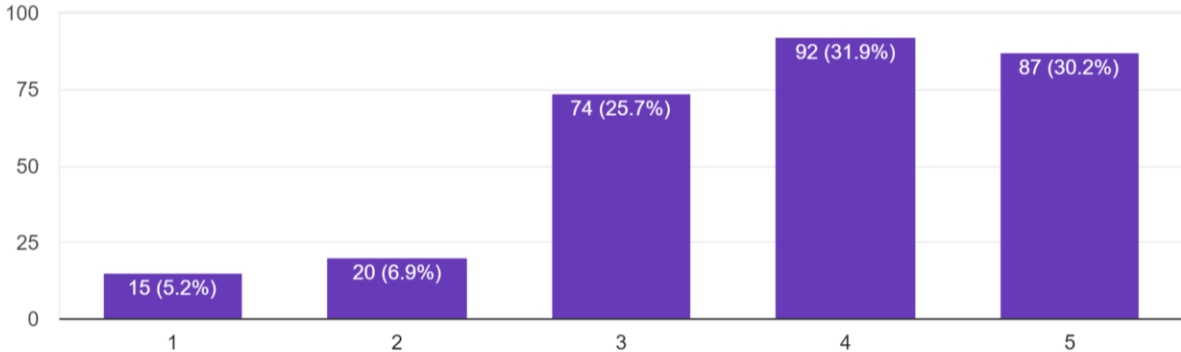
The following sections outline the key findings from the survey, including quantitative results from the multiple-choice questions as well as comments derived from participants' freeform suggestions.

1 – Not Worried....5 – Very Worried

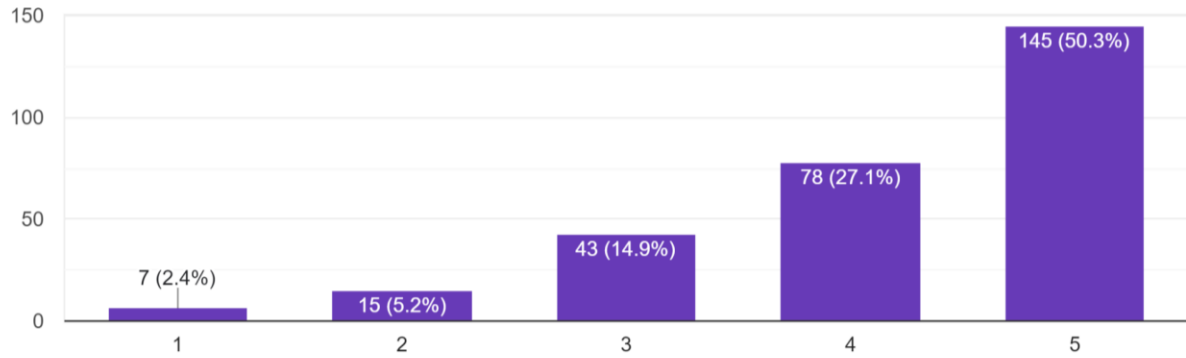

1 – Not Concerned....5 – Very Concerned

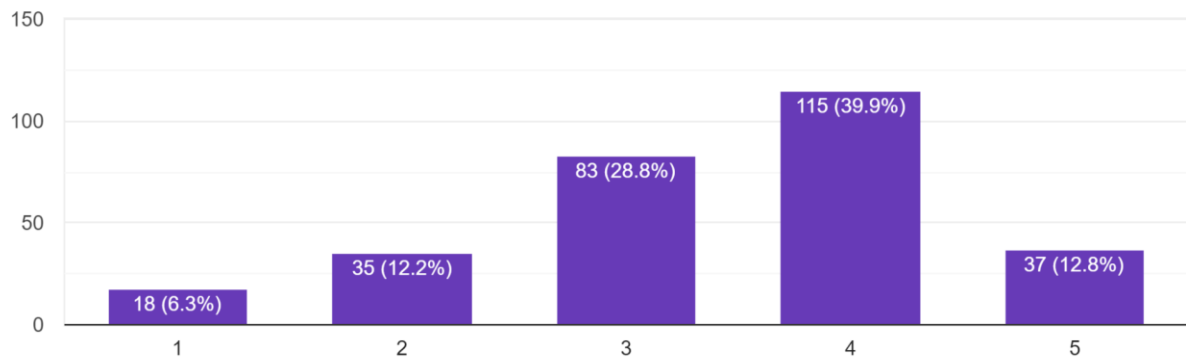

1 – Not Prepared....5 – Very Prepared

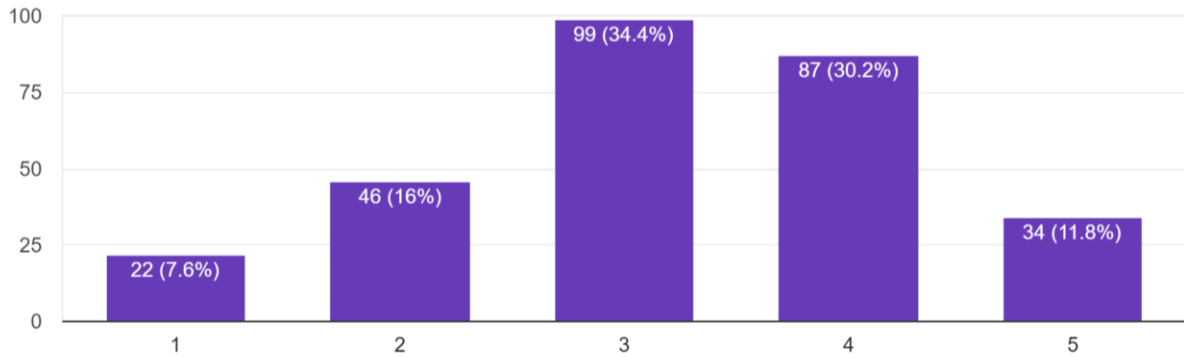

1 – Not Satisfied....5 – Very Satisfied

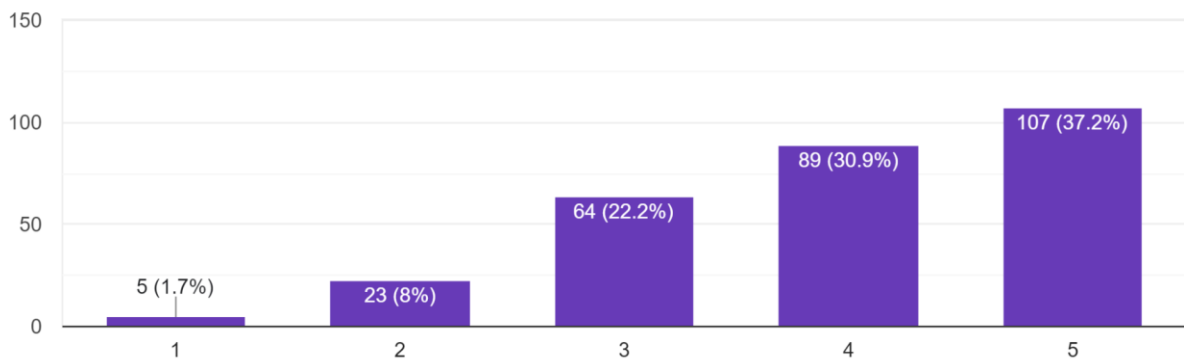

1 – Not Worried....5 – Very Worried

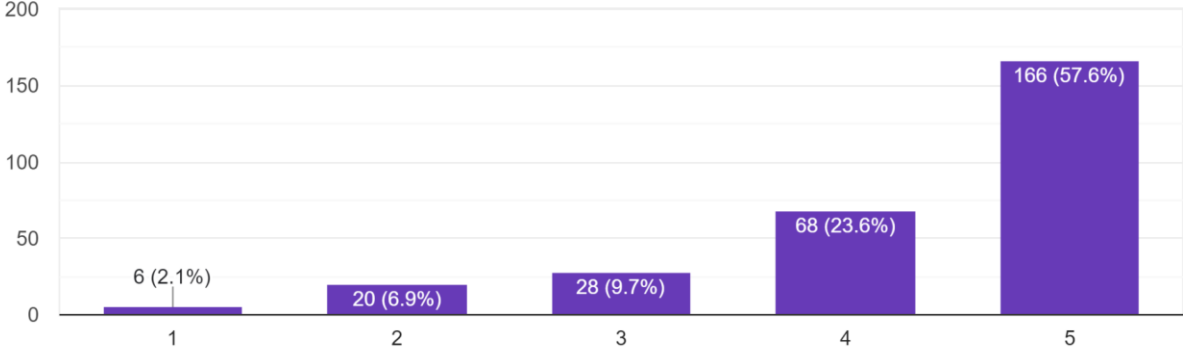

Freeform Responses

In the following sections participants were able to respond to the following questions:

- “Other concerns: Please write in any other concerns you have related to forest fires or smoke not listed above.”
- “What information or resources would be most helpful to you in preparing for future wildfires?”
- “Are there any vulnerable populations in our community who may need additional support during wildfire events?”
- “What specific challenges do you face in staying informed or prepared for wildfires?”

Other Concerns

The written comments raise a variety of concerns about wildfires in Chelan County. Here's a breakdown of the key points:

Fire risk and prevention

- Dense forests and dead trees increase fire risk.
- People not understanding fire risks or following fire restrictions.
- Lack of forest management, thinning, and controlled burns.
- Short-term rentals and uninformed visitors pose a risk.
- Concerns about the effectiveness of the "let it burn" policy for remote fires.
- Need for more education and outreach about fire preparedness.

Evacuation planning and infrastructure

- Limited evacuation routes and potential gridlock during fires.
- Dead-end roads and lack of secondary exits for some neighborhoods.
- Concerns about evacuation from tourist areas during peak season.
- Lack of evacuation plans for some areas.

Communication and information

- Difficulty getting timely and accurate information during wildfires.
- Need for multiple communication channels (web, phone, radio) that don't rely on internet.
- Public confusion about fire restrictions and air quality updates.

Insurance

- Difficulty obtaining or keeping fire insurance due to high risk.
- Impact of fire risk on property values.

Other concerns

- Impact of smoke from wildfires on air quality and health.
- Lack of fire hydrants in some areas.
- Response times for firefighters, particularly to outlying areas.

The comments also offer some suggestions for improvement, such as:

- More aggressive forest management, thinning, and controlled burns.
- Improved evacuation planning and infrastructure.
- Better public education and outreach about fire preparedness and evacuation procedures.
- More reliable communication channels during wildfires.
- Addressing the issue of rising insurance costs in high-risk areas.

Overall, the comments highlight the significant concern about wildfires in Chelan County and the need for a comprehensive approach to prevention, preparedness, response, and recovery.

Need for More Information or Resources

Many comments highlighted several key areas where residents would like more information and resources:

- **Evacuation planning and procedures:** Many people are concerned about evacuation routes, especially during peak tourist season. There is a desire for clear and concise evacuation plans that are communicated effectively.
- **Communication during wildfires:** Residents want timely and accurate information during wildfires, especially if traditional channels like social media are unavailable. Many prefer alerts via text message, email, or a dedicated website.
- **Defensible space:** There is interest in creating defensible space around homes, but some residents find it difficult or expensive to clear brush and debris. Financial assistance and chipping programs are seen as helpful resources.
- **Forest management:** Many comments call for more aggressive forest management, including thinning and controlled burns, to reduce fire risk.
- **Public education and outreach:** Residents would benefit from educational programs about fire preparedness, evacuation procedures, and creating defensible space.

Here are some additional insights from the comments:

- Some residents expressed frustration with the current communication methods used by fire agencies during wildfires.
- There is a concern about the rising cost of fire insurance and the impact of wildfires on property values.
- A few comments mentioned the need for better monitoring of illegal burning and better visibility of fire hydrants.

- Some residents praised existing programs, such as the Lake Wenatchee Fire & Rescue chipping service and firewise programs.

Overall, the comments show a strong desire for more collaboration between residents and fire agencies to improve wildfire preparedness in Chelan County.

Vulnerable Populations

Analysis of wildfire vulnerable populations in Chelan County

The comments overwhelmingly acknowledge that there are vulnerable populations in Chelan County who require additional support during wildfires. Here's a breakdown of the identified groups:

- **Age:**
 - Elderly residents, especially those living alone or with mobility limitations.
 - Children who may be home alone when parents are working.
- **Location:**
 - Residents of assisted living facilities and group homes.
 - People living in remote areas with limited evacuation routes or single access points.
 - Vacation rental guests unfamiliar with the area and evacuation procedures.
- **Health:**
 - People with underlying respiratory conditions who are more susceptible to smoke inhalation.
 - People with disabilities or limited mobility who may struggle to evacuate.
- **Socioeconomic factors:**
 - Low-income residents who may not have resources for transportation for evacuation.
 - Non-English speaking residents who may have difficulty understanding emergency information.
 - Homeless population.

There are also concerns about:

- **Pets and livestock:** Evacuation plans and shelters for animals during wildfires.
- **Uninformed populations:**
 - Residents who don't use social media and rely on alternative information sources.
 - Tourists and visitors unfamiliar with wildfire risks and evacuation procedures.

Recommendations

The comments suggest several ways to improve support for vulnerable populations:

- **Develop a comprehensive evacuation plan:** This plan should include
 - Strategies for evacuating people from assisted living facilities, group homes, and remote areas.
 - Utilizing public transportation (school buses) for mass evacuations.
 - Identifying alternative evacuation routes to avoid congestion.
- **Targeted outreach and education:**
 - Create informative materials (pamphlets) for vacation rentals explaining wildfire risks and evacuation procedures.
 - Provide public education programs in multiple languages.
 - Conduct outreach to elderly residents and those with disabilities to assess their needs and develop support plans.
- **Vulnerable person registry:** Consider creating a registry of vulnerable residents who may need extra assistance during evacuations.
- **Volunteer network:** Establish a network of volunteers to help vulnerable residents with evacuation and other needs.
- **Communication efforts:** Ensure multiple channels are used to disseminate emergency information, including for non-English speakers.
- **Animal shelters:** Develop plans for sheltering pets and livestock during wildfires.
- **Financial assistance:** Provide financial assistance programs to help low-income residents prepare their properties and evacuate if necessary.

By implementing these recommendations, Chelan County can ensure a more inclusive and effective emergency response system that considers the needs of all residents during wildfires.

Challenges

Analysis of wildfire preparedness comments in Chelan County

The comments highlight several key challenges faced by residents in staying informed and prepared for wildfires. Here's a breakdown of the main themes:

- **Communication Issues:**
 - Inconsistent and slow updates from agencies during fires.
 - Reliance on social media (particularly Facebook) which not everyone uses.
 - Poor radio reception and concerns about outdated information on websites.
 - Difficulty for non-permanent residents to stay informed.
- **Information Access:**
 - Lack of a centralized source for accurate and up-to-date information.
 - Difficulty finding information during power or internet outages.

- Need for more education on fire preparedness, defensible space, and resources available.
- **Evacuation Concerns:**
 - Limited evacuation routes and potential congestion on Highway 2.
 - Lack of awareness about evacuation plans, especially for non-residents.
- **Other Challenges:**
 - Physical limitations for some residents to prepare their properties.
 - Concerns about smoke impacting health, especially for vulnerable populations.
 - Inaccurate information circulating on social media.
 - Disagreement on the timing of forest management activities (chipping, burning).

The comments also reveal some positive aspects:

- Residents who actively seek out information and participate in preparedness programs.
- Appreciation for existing programs like chipping services and firewise initiatives.
- Recognition of the importance of defensible space and riparian vegetation protection.

Recommendations

Based on the comments, here are some recommendations for improving wildfire preparedness in Chelan County:

- Develop a **centralized information system** with real-time updates accessible through multiple channels (website, text alerts, radio).
- Increase focus on **outreach and education** through diverse channels, including non-social media platforms.
- Ensure **clear and consistent communication** during wildfires, with emphasis on evacuation procedures.
- Conduct **regular public meetings** to discuss fire risks, preparedness, and evacuation plans.
- Explore the feasibility of **alternative evacuation routes** and resident education on using them.
- Offer **assistance programs** for elderly or physically limited residents to create defensible space.
- Partner with local media to provide **accurate and timely information** during wildfires.
- Conduct a **communication needs assessment** to understand resident preferences for receiving information.

By addressing these challenges and implementing the recommendations, Chelan County can empower residents to be better prepared for wildfires.
