RESOLUTION NO. 2014 - 2014-32

A RESOLUTION amending Resolution 2012-120, regulating snowmobile use on county roads.

WHEREAS, the Board of Chelan County Commissioners desires to add a new section to Chapter 9.40 of the County Code, to be codified as 9.40.015, for the purpose of designating county roads open and closed to snowmobile use and to eliminate the need to annually republish the list of such roads; and

WHEREAS, the Board finds that Oklahoma Gulch Road runs through mule deer winter range with a dense population of the animals, and for the protection of such wildlife, Oklahoma Gulch Road should be permanently closed to snowmobile traffic; and

BE IT RESOLVED that Resolution 2012-120 (Exhibit A (part)), is amended and a new section added as set out in Exhibit A to this resolution.

BE IT FURTHER RESOLVED that this Resolution shall become effective on April 1, 2014.

9.40.020 Closing county roads to snowmobile use.

- (1) The Board of County Commissioners may at any time close any county road previously open to snowmobile traffic when the Board determines that closure is necessary for public safety or convenience, the safety of snowmobile operators, the protection of wildlife, or the best interest or convenience of the county.
- (2) The County Engineer is authorized to close or restrict snowmobile traffic upon any county road at any time for emergencies, provided that such restriction or closure is reported immediately to the Board of County Commissioners.
- (3) The County Engineer is authorized and directed to erect appropriate signs providing notice of closure or restriction of roads for snowmobile use; except, the Washington State Department of Fish and Wildlife is authorized to erect appropriate signs providing notice of road closure or restriction under this chapter for the protection of wildlife. The County Engineer is further authorized and directed to post notice on the county website of closure or restriction of roads to snowmobile use.
