Sheriff Burnett is pleased to announce that two of his Chelan County Deputies have been chosen to receive the Washington State Law Enforcement Medal of Honor. Deputies Adam Musgrove and Ryan Moody will receive their awards at the Law Enforcement Memorial site on the State Capitol Campus in Olympia, Washington in early May of this year.

The Deputies were nominated by the Chelan County Sheriff's Administration for saving the life of a man who was found in his burning home in Chelan and suffering from what was believed to be mental health issues. With flames beginning to consume the structure and neighbors yelling that the home owner was still inside, both deputies entered the burning home. They found the home owner lying on the floor, which was now beginning to be consumed by flames. With flames surrounding the deputies, they carried the man from the burning home to safety. Their selfless act of courage saved the man's life which would have most assuredly ended in tragedy.

Deputy Musgrove started his employment with the Chelan County Sheriff's Office in March of 2012 after loyally serving the Sedro Woolly Police Department since 2006.

Deputy Moody started his employment with the Chelan County Sheriff's Office in May of 2012 after loyally serving the Monroe Police Department since 2002.

Both Deputy Musgrove and Deputy Moody received a separate award from Chelan County Fire District 7 in Chelan for their heroic actions. They also received "Hometown Hero" awards through the American Red Cross Apple Valley Chapter in April.

The Washington State Law Enforcement Medal of Honor was established in 1994 through the Washington State Legislature. This honor is reserved for police officers who have been killed
