Sheriff Brian Burnett reports that he attended the 28th Annual Law Enforcement Ceremony on Tuesday, May 12, 2015 in Spokane Washington. Sheriff Burnett was invited by the Law Enforcement Memorial Project coordinators to participate in the eulogy for Chelan County Sheriff's Deputy James M. Bennett.

One of the objectives for the memorial project is for them to identify any Law Enforcement Officers that have died in the line of duty within Washington State but have yet to be honored and their name added to the memorial wall.

Deputy James M. Bennett, 38 years of age, died in the line of duty on July 14, 1911 several miles north of Chelan while he and another deputy were en route to serve a warrant on a shepherd who had been grazing his sheep on another farmer's land. During the trip, Deputy Bennett dismounted his horse to get a drink from a spring, as he leaned over; his .38 caliber Colt revolver fell from the holster and discharged. Deputy Bennett was survived by his wife Anna, sons Samuel (11), Claude (9), Carlisle (6) and his infant daughter Elsie Bennett Richardson.

James wife, Anna, passed away in 1915, from what family members stated was a broken heart and that she never fully recovered from the loss of her husband.

Deputy James Bennett joins both Chelan County Sheriff's Deputy Scott Edie and Deputy Saul Gallegos who all have their names engraved on the memorial wall in Spokane.


